

ENTRY REGULATIONS

The Central States Excellence in Design Awards celebrates outstanding work in the Central States region of Iowa, Kansas, Missouri, Nebraska, and Oklahoma. Entries must be designed by licensed architects who are located within the Central States region, or must be projects located within the Central States region designed by licensed architects located anywhere. Award recipients will be announced at the Central States Excellence in Design Awards Celebration on Friday, September 13, 2024 in Springfield, Missouri.

Entry Categories

Architecture Interior Architecture Urban Design & Planning Unbuilt Work

Eligibility

- 1. Eligible projects include any project designed by a licensed architect or firm located in the Central States region and can be located anywhere in the world; or projects located within the Central States region and designed by a licensed architect or firm located anywhere.
- 2. A firm may enter as many projects as they desire.
- 3. Projects previously honored in the Central States Excellence in Design Awards program are not eligible for submission; however, UNBUILT projects previously awarded may be submitted as BUILT work for consideration.
- 4. Eligible BUILT projects must be substantially complete after January 1, 2019.
- 5. Eligible UNBUILT projects must be designed after January 1, 2019.
- 6. In the case of collaborative work among associated architects or firms, the entrant must be able to claim design authorship for the submission, and the collaborating architect/firm shall be granted appropriate credit on the concealed identification form, and provide signature of approval.

Release of Submission Material

It is the entrant's responsibility to ensure that all submission material, including professional photographs, is cleared for release and use by the entrant and AIA Springfield. Entering a submission constitutes written permission for AIA Springfield to use all information included for the Design Awards program including publication and archival purposes.



Judging

The Jury will be chaired by Karen Fairbanks, FAIA of Marble Fairbanks and include additional respected professionals from the architectural community outside the Central States region. Additional jurors will be announced at a later date.

All judging is anonymous. No submission shall include any name of the design team in the Descriptive Data or the PDF Presentation. Firms and/or team member names are to be included on the Concealed Identification form only. Failure to do so may be grounds for disqualification.

The Jury is not obligated to present any awards. In addition, the Jury reserves the right to award all award designations, including special awards at its own discretion; however, it is not obligated to do so. Each entry will be judged for the success with which the project has met its individual requirements.

Certificates will be prepared for the architects of each entry receiving award(s) and will be presented at the Awards Celebration on September 13, 2024.

SUBMISSION REQUIREMENTS

Please read all submission requirements thoroughly.

All submissions will be required to be in a 16:9 PDF file with consistent visual size per slide. AIA Springfield reserves the right to review the submission for compliance with the submission requirements prior to the jury's review. General information follows:

Concealed Identification and Release

Concealed Identification Sheet with a listing of project name and location, project owner/client, name of submitting firm and firm personnel involved and roles, engineering consultants, other consultants, general contractor, and other credits for the design of the project to be scanned with signatures and saved in PDF format and

uploaded to an AIA Springfield file sharing site to be provided. information will be used for credits on awards citations, news releases, and publications. This file is for the use of the Design Awards Committee only and will be removed from the submission prior to judging.

Release Form (bottom portion of Concealed Identification sheet) with signed releases by the entrant(s), and the copyright holder or photographer. For all material included in the entry, the entrant must obtain releases enabling reproduction for the component's publicity.



Project Attributes

On the first slide of the PDF Presentation (see below), provide the following information in list order:

A Project Attribute is required when denoted with an asterisk (*).

Descriptive Data

A clear, concise synopsis of 300 words or less, to be located on the first page of the PDF presentation (see description below) and uploaded to an AIA Springfield file sharing site summarizing principal features that merit recognition in the program. Descriptions should demonstrate a holistic vision for the design as it relates to the AIA Framework for Design Excellence, including: Design for Integration, Design for Equitable Communities, Design for Ecosystems, Design for Water, Design for Economy, Design for Energy, Design for Well-being, Design for Resources, Design for Change, and/or Design for Discovery. Although addressing every measure is not required, a compelling design solution should integrate design excellence and sustainable performance. Entrants are encouraged to use the Framework to assist with project narratives.

PDF Presentations

Entrants should include a 1920 X 1080 pixels PDF presentation, landscape oriented, 25MB limit. PDF presentation limited to 15 slides, not including the first slide - Descriptive Data. The PDF may include succinct, descriptive captions on each slide, as required to explain the project. presentations will be viewed via projection screen, so please be mindful of



formatting and resolution, as well as providing enough information for clarity of design intent. Your project will be judged on its comprehensive design, including the quality of the presentation and clarity of the design story.

Graphics may be drawn at any scale and with any medium, and images of models and drawings are also encouraged. PDFs with embedded audio, video, or other interactive features are not allowed. At least one floor plan drawing shall be provided. A site plan drawing shall also be required for all projects except those of an interior only nature. There is no minimum number of slides required; however, it is important for each entry to have sufficient information explaining the project, because each entry will be judged based on individual merit.

PDF Presentations will be retained by the Chapter for future use and publicity.

Judging Criteria

In accordance with our mission statement to recognize the importance of excellence in architecture, and in an effort to align with AIA National's Framework for Design Excellence, each entry will be judged for the success with which the project has met its individual requirements with emphasis on design excellence, which includes aesthetics, performance, community connectivity, resilience, and stewardship of the natural environment. Entries will be weighed individually, not in competition with each other.

Publicity

Awards are an expression of recognition for superior performance. They communicate the message that good architecture is to be valued in the community. Since the buildings address a public audience on a daily basis, they should serve to educate, inform and increase the public awareness of the importance of good design. When properly publicized, awards contribute to a better understanding of and appreciation for the work architects perform.

AIA Springfield will publish all entries in a printed design publication. In addition, submissions will be exhibited at local conventions and trade shows as those opportunities present themselves.

Promotional Images

In addition to the PDF presentation, entrants are required to submit four (4) high resolution images of the project for use by the Component for publication purposes. Provide two (2) vertical and two (2) horizontal images of your choosing for publication. Images must be .jpeg or .png format and a minimum of 8"x10" and at least 300 dpi. Images will be uploaded at the same time as your submission.

All projects submitted are of great value to the users and the community. Whether or not a project wins an award is not as important as the role it plays in society. The building will be used for years to come and should be seen for how it affects daily life for the public now, as well as into the future.



Awards Celebration

The Central States Excellence in Design Awards Celebration is hosted by AIA Springfield and will coincide with the AIA Springfield Design Awards Celebration, including lectures by Karen Fairbanks, FAIA of Marble Fairbanks in New York and Edwin Harris, AIA of Evoke Studio in Durham, NC, along with other tours and events on September 13 and 14, 2004 in Springfield, Missouri. FAQs

Will an entry be disqualified if it does not meet all Project Attributes?

No, an entry will not be disqualified if it does not meet all Project Attributes. Please see the list of Project Attributes for attributes that are required and optional. If information is unknown for an optional Project Attribute, please write "Unknown" next to the Project Attribute on the first slide of the PDF Presentation.

If an entry previously submitted in the Central States Excellence in Design Awards program received an award in one category, is the entry eligible to be submitted in a different category?

A BUILT project entry that has previously received an award from the Central States Excellence in Design Awards program is **not** eligible for resubmission; however, a project previously awarded as an UNBUILT project may be resubmitted as BUILT work (Architecture, Interior Architecture, or Urban Design & Planning) for consideration.

Should a master planning project be entered as "Unbuilt Work" or "Urban Design and Planning"?

A master planning project, UNBUILT or BUILT, may be entered under the "Urban Design and Planning" category as this category encapsulates all planning contexts (rural, suburban, urban, etc.).
